Firms

operating in the region have adjusted their practices in response to both crash volume and recent changes in state law.

Georgia's legal framework changed with the enactment of Senate Bill 68, signed April 21, 2025. The legislation revised how medical damages are calculated, how fault is apportioned among parties, and how non-economic damages are presented in personal injury cases statewide. The measure took effect for cases filed after its enactment and applies to personal injury litigation across Georgia.

"The Expertise.com methodology looks at the parts of legal work that clients experience directly, including verified reviews, responsiveness, and availability, rather than standing among peers alone," said David Hodgins, Attorney at Hodgins & Kiber. "Those are the dimensions this firm has organized its Atlanta practice around, staying accessible, communicating proactively, and making sure clients understand their case at every stage. Under SB 68, the framework calls for more rigorous claim-building from the outset, and this firm approaches case preparation with that requirement in mind."
