



RestoPros of Northeast Georgia Named 2025 Best of Gwinnett Winner

LAWRENCEVILLE, GA - April 20, 2026 -

RestoPros of Northeast Georgia has been named a 2025 Best of Gwinnett winner for the fifth consecutive year, earning recognition through the annual community-voted awards program administered by Guide to Gwinnett. The results were officially announced on February 14, 2026, following a yearlong voting period in which hundreds of thousands of votes were cast across more than 25 industry and community categories throughout Gwinnett County.

The Best of Gwinnett program, published by Gwinnett Magazine, evaluates businesses through a process combining reader votes, editor assessments, vote pattern analysis, and business ranking services. Winners are recognized at three tier levels and featured in an annual print publication distributed across the county. The program has served as a resource for area residents seeking vetted local businesses for more than two decades, with the 2025 print annual scheduled for distribution in March 2026.

For RestoPros of Northeast Georgia, the five-year streak spans every year of the company's operation since its founding in 2021.

RestoPros of Northeast Georgia is an IICRC-certified restoration company providing water damage restoration, mold remediation, and fire damage restoration services to residential and commercial properties throughout the region. Founded in July 2021, the family-owned and locally operated company maintains around-the-clock emergency availability with an average response time of approximately 60 minutes within its coverage area. The award marks consecutive years of the company receiving the Best of Gwinnett designation, reflecting sustained community support from property owners who have relied on the company's restoration services.

The restoration industry in Gwinnett County includes several national franchise operations alongside independent and locally owned providers. Community-voted recognition programs such as Best of Gwinnett offer residents one measure for evaluating service providers in specialized trades where certification standards, response times, and claims expertise can vary significantly between companies.

"This recognition means a great deal to our team because it comes directly from the community we serve every day," said Burke Allen, Co-Owner of RestoPros of Northeast Georgia. "We built this company to be a dependable resource for our neighbors, and knowing that effort resonates is what keeps our team focused on the work."

The company holds IICRC firm-level certifications in all three of its primary service areas, and each technician maintains individual certification through the Institute of Inspection, Cleaning, and Restoration Certification. Water damage restoration remains the company's most-requested service, addressing situations ranging from burst pipes and sump pump failures to heavy rain flooding and sewage backups. The structured mitigation process follows established industry protocols, including emergency assessment, commercial-grade water extraction, structural drying with ongoing moisture monitoring, and full coordination with insurance providers throughout the claims process.

Beyond its core restoration services, the company offers third-party asbestos testing on every project and uses Xactimate estimating software to support pricing transparency during insurance claims. The approach allows the team to concentrate its resources on the specialized extraction, drying, and remediation work that falls within its certified scope of expertise.

The company serves Lawrenceville and surrounding communities including Suwanee, Snellville, Dacula, Duluth, Alpharetta, and Buford. As a locally owned operation competing in a market alongside national restoration franchises, the company has built its client base through direct community engagement, consistent emergency availability, and a family-ownership structure that positions it as a locally accountable option for property owners navigating time-sensitive damage situations.
